#### WHO WE ARE AND HOW TO CONTACT US

This Privacy Policy describes the types of information that we collect; how and for what purposes we collect it; how we protect, use, and share it; and your choices and rights regarding it. By providing information to us or by using our website, you agree to the collection and use of information in accordance with this Privacy Policy.

#### INFORMATION YOU PROVIDE DIRECTLY

We collect, store, and process information about you that you provide to us when you:

- Use our website (for example by filling in a form or browsing while electronic data collection tools are enabled on your device);
- Contact us by telephone or in person (for example, to inquire about or to order our products);
- Send us a letter, email, social media message, or filled-in form;
- Subscribe to receive a service from us (for example, product information) or follow us on social media;

The type of information we may obtain includes:

- Your order for, purchases of, and payment for our products, including method of payment (for example, credit or debit card number or bank transfer information) and shipping information;
- Information relevant to your employment, or your application of employment, if you are applying for a job; and
- Information relevant to your trade or wholesale account status, or your application for trade or wholesale account status, with us.

We do not collect (unless you volunteer it) information on racial or ethnic origin; opinions such as on politics or religion; health; or membership in organizations (for example, interest groups or labor unions).

# INFORMATION WE COLLECT ELECTRONICALLY

When you visit our website, we may collect certain information through automated means. Such information may include:

- The date and time of your website visit;
- The pages that you visit on our website and the time that you spend on them;
- The internet protocol address of your computer or other devices, and/or other unique device identifiers;

## COOKIES

# THIRD PARTY SERVICE PROVIDERS

- To protect and defend our legal rights and property;
- To prevent or investigate possible wrongdoing in connection with our website; and
- To protect against legal liability.

We reserve the right to transfer information about you in the event that we sell or transfer all or a portion of our business or assets, in accordance with applicable law. Should such sale or transfer occur, we will use reasonable efforts to ensure that the transferee uses information you have provided to us in a manner that is consistent with our Privacy Policy. Following such a sale or transfer, you may contact the entity to which we transferred your information with any inquiries concerning the processing of that information.

## HOW WE PROTECT INFORMATION

The security of your information is important to us. While we strive to use commercially acceptable means to protect your personal information, we cannot guarantee its absolute security because no method of transmission over the internet and no method of electronic storage is considered to be 100% secure. #### YOUR RIGHTS

Deletion will not affect any processing already begun; nor will it extract non-identifiable information about you from any aggregated, anonymized, data set. We will not be able to remove your information from the database of third parties with whom we have already shared information, with your consent. You also have the right to a copy of your personal information that we hold in a commonly used electronic format so that you can manage it. We may ask you to verify your identity before responding to such requests. You also have the right to request that we cease sending marketing communications, whether by email or otherwise, to you.
